The Carlisle Township Board of Trustees met on August 15th, 2024 at 7:00 PM. In attendance: Trustee, James Wright, Trustee, Berry Taylor, Trustee, Jared Smith, Fiscal Officer, Kelsey Sizemore, Administrative Assistant, William Oliver, Zoning Inspector, Tim Ehrke, Road Superintendent, Paul Sniezek, and Fire Chief, Steve Higgins. Mardun Survey Results

Survey has been completed and stacked out, Paul Sniezek, gave the packet of information to the Trustees.

Trustee Smith asked if there was enough room for a runaround, Paul said yes. It would be a "T" shape at the N.W. Corner of Indian Hollow Road & Mardun. One of the residents at the end of Mardun has a concern with losing some parking near her driveway. Residents also expressed their concern about how wide it needs to be. Paul said it must be within the right-of-way. Residents further expressed concerned about a turn around and having a firetruck have room to turn around. Chief Higgins exclaimed that he will check out road with Paul.

Albers & Albers Law Firm / Home Rule Resolutions

Trustee Smith exclaimed that Albers & Albers will drafting our Home Rule Resolutions. This is the Law that the township hired months ago to help the township with Home Rule. Trustee Wright commented various examples on how properties are not taken care of or become neglected by the owner and the series of said events that the Township endures because of it. This is something that needs to be addressed.

Tonight, during the meeting, Trustee Smith read all the resolutions aloud that the Attorney drafted and stated that these will be read again. As a Home Rule Township, the resolutions need to read out load twice. There will be two types of publications one in the paper, and one online; 1st Resolution Trustee Smith read aloud. Once finished, he read the second and third one. Once Trustee Smith finished reading these aloud, he stated that we will be getting these published to paper and, also onto our website for all residents to read.
